2011 PSP Change Announcements Important Notification!

Updating of the PSP® Exam Eligibility, Test Forms & Reference Materials

ASIS International has announced important 2011 updates to the exam eligibility, test forms, and reference requirements for the Professional Security Professional (PSP®) certification. These changes will take effect on November 7, 2011.

Please note that PSP® passing requirements have not changed at all, but the exam content has been updated based on the new job analysis. The change in eligibility requirements and exam content is reflective of physical security professionals who are more experienced and/or exposed to increasingly advanced concepts. It also ensures that the exam is on par with employer requirements and enhances the worldwide value of all ASIS certified professionals. Such program enhancements are expected as industries expand and candidates are required to demonstrate competence in specified tasks. In fact, it has occurred with the Certified Protection Professional program, which has undergone similar changes in the past quarter century.

2011 Eligibility Requirements

Updated Test Forms

Approved computer-based test (CBT) candidates (still within their two-year eligibility test period) have between now and November 5, 2011 to take the existing exam, based on current references. CBT candidates, both current and retests, should allow enough time to schedule their exam and retest if necessary. Paper and pencil candidates have two opportunities to test in 2011 before the change goes into effect -- May 7 and November 5. The domains of study, which highlight skills, tasks, and knowledge areas covered on the exam may be viewed online. Also see important FAQs.

PSP® Reference Books

The PCB has also released the list of reference materials for the 2011 PSP® exams. We ask that all regional and chapter leaders make candidates and study/review course program directors aware of the changes. The study reference update to note is the adoption of the new ASIS Facilities Physical Security Guideline in place of the Army Field Manual. Other reference materials remained unchanged at this time. This updating helps to ensure that the references remain current and accurately reflect the security environment. All questions on the exams are taken from the reference books only; so it is important to note this change!

Reminders to Sponsor P&P Exams in May and November 2011

May and November 2011 paper and pencil (P&P) exams will be administered for these locations: Ecuador, Jamaica, New Zealand, Panama, and Trinidad/ Tobago. If your location does not have a Prometric computer-based testing (CBT) center and your chapter wishes to sponsor a P&P exam, please contact the certification staff at certification@asisonline.org. You may also view request to sponsor information and deadlines in the certification section of the website.

Test date: May 7, 2011

Application submission deadline date: March 1, 2011

Test date: November 5, 2011

Application submission deadline date: September 1, 2011

Request to sponsor forms should be submitted no later than January 31, 2011 for May and July 31, 2011 for November.

Important Recertification Reminder!

ASIS International headquarters will close on December 24, 2010 and will reopen on January 3, 2011.

If you are due to recertify within this time period, you will not be penalized. Please note that you have a grace period until **January 31, 2011** within which to submit recertification documentation.

Here are some ideas for earning recertification credits if you are still shy of your required CPE requirements:

Memberships

If you belong to a security or business management-related organization, you can earn CPE credits.

Chapter Meeting Attendance

Earn CPE credits for attending Chapter educational meetings of any length (minimum of 50 minutes). Webbased training may be claimed with no maximum limit.

Virtual forums

This is a cost-effective way to earn credits as registration fee is per site and several instead of just one person can reap the benefits.

Instructor Credit

Ensure that the course topic is relevant to the practice of security (or study domains) so that your credits may be claimed.

Accredited College Courses

Security/management-related accredited college courses as well as self study programs that result in accredited college or university credit can be submitted.

Safety-related Programs

Attendance or speaking/teaching in the areas of safety, environmental safety fire prevention and personal protection single and multiple-day seminars and conferences may be claimed for CPE credits. (Up to 21 CPE Credits per term)

Seminar/Conference attendance

It is very important to remember to claim your credits for attending security and management single and multiple-day seminars and conferences.

Author of a book or article

As long as the topics are relevant to the practice of security and related to the domains of study for each certification, you can earn CPE credits.

Program Services

Participate in an Item Development Group, Pass Point Study or Role Delineation (job analysis) preparation and your activity will count toward your credits. Membership in an ASIS Council and the Guidelines Commission is also eligible for CPE credits

Public Service

Some eligible activities to keep in mind include those for a charitable, religious, governmental or community entity that are performed pro-bono.

New examples of eligible activities are often added, so please note that the above list is not exclusive. When in doubt, submit a description of your activities to the recertification staff at certification@asisonline.org for CPE approval.


Certification Lounge Highlights
