# Guest Speaker April 2010 – Dr. Joe Heck

April's guest speaker was Dr. Joe Heck with the Center for Disease Control speaking on the topic of "Bombings: Awareness, Injury Patterns, and Care"

Dr. Heck offered a highly condensed presentation regarding some of the potential effects of



bombings and some suggestions on who might be expected to respond and how they might be required to do so. Dr. Heck defined terrorism according to the CDCs definition

Terrorism can be defined as containing four key elements.

It is premeditated—planned in advance, rather than an impulsive act of rage.

It is political—not criminal but designed to change the existing political order.

It is aimed at civilians—not at military targets or combat ready troops.

It is carried out by sub-national

groups—not by the army of a country.

There are several Types of Terrorism including religious terrorism, state sponsored terrorism and suicide terrorism.

Dr. Heck pointed out that bombings are more frequent than we might suspect and that in this or any emergency situation, we are likely to be relied on to respond. In emergency situations, there may such a significant need for assistance to those involved, that it is likely there will not be sufficient professional personnel to respond, or there may be delays.

Victims may be unwilling or un-

able to cooperate and we are likely to be put into situations to guide and assist them.

Some, but not all, tips include:

- Inform individuals responding not to rush into the site—secondary attacks can occur. Instruct bystanders to move away from the area and to avoid potential targets
- Most injuries in a bombing are not life-threatening and are due to blunt and penetrating trauma from flying debris or bomb fragments. Wounds can be grossly contaminated. Consider delayed primary closure and assess tetanus status.
- Communication with bomb-

ing victims may be difficult, as they often experience ringing



in the ears and/or sudden temporary or permanent hearing loss.

• Explosions in closed spaces, such as in subways or buses,

or combined with a building or structural collapse, result in a

greater number of severe injuries and deaths.

- Those less injured bypass EMS triage and go directly to the closest hospitals and arrive before the more severely injured.
- Hospitals and roads closest to the blast(s) will
  quickly become crowded, as
  a large number or surge of
  friends and loved ones will
  arrive at the closest hospital
  within minutes of the event.
   When possible, individuals

with minor injuries should be directed to hospitals outside the immediate area of the blast.

For those familiar with Dean Hill and his dedication and




enthusiasm it is unlikely to come as a surprise that he was

potential for chemical and/or radiological contamination. Triage and life saving treatment should never be delayed because of the possibility of radioactive contamination of the victim. In general, the risk of exposure to caregivers is small.

Dr. Heck reviewed the triage

process and how we might make determinations regarding who is in the most immediate need of assistance, and who may be able to assist themselves.

Dr. Heck reminded us that we must put our safety first when responding. This includes making contact with loved ones to alleviate unnecessary concern and to allow our available resources to be more thoroughly

engaged in the emergency rather than secondary concerns.


instead of waiting for someone else to do it.

<sup>\*</sup>Notes: The beginning balance of the savings account was adjusted by \$0.20 from the ending balance recorded on last month's treasury report to compensate for an error on the January report and to reflect accurate YTD interest payments, which were estimated on the first three 2010 treasury reports. However, the balance of the savings account still varies significantly from the current bank statement. Online review of savings account activity has failed to account for the variance. Since the first quarter audit is pending, the variance will be reported to the auditor in the hopes that further investigation will isolate the source. A less significant variance appears in the checking account balance, which will also be reported to the auditor. This variance might be attributable to \$129.94 of expenses incurred in December of 2009, which do not appear on the treasury report, but further investigation will be required to verify.
