## Guest Speaker June 2010— Russell Stoddard

June's guest speaker was Russell Stoddard from the U.S. Department of Homeland Security (DHS) and the Immigration and Customs Enforcement (ICE) branch. Russell spoke to the group regarding the many departments in the DHS and the local capabilities of the departments. Locally there is one Resident Agent in Charge, eight Special agents, and one

## Reno Police Department's Traffic Division

### Reno Police Department's Traffic Division uses Data-Driven approach to crime and traffic safety

The Reno Police Department's Traffic Division has been using "Traffic Crash Analysis Report or "TCAR" as an effective tool in reducing traffic crashes and addressing crash causing factors, such as driver behavior, environmental conditions or engineering issues.

The Traffic Crash Analysis Report identifies the top (usually ten) crash locations as well as factors which contributed to those crashes. The timely and accurate data provides place-based, current crash and traffic related information which is used to strategically deploy resources.

High visibility traffic enforcement, led by the "Crash Reduction Team" (CRT) is then implemented with a specific focus on impacting the top crash locations and reducing injury related crashes. During high visibility enforcement, traffic officers utilize the "3Es" of traffic enforcement; education, enforcement and engineering.

As an example of the effectiveness of this approach, at the beginning

of April 2010, TCAR identified the top ten injury crash intersections within the City of Reno as:

- 1 - S. McCarran / S. Virginia
- 2 - Robb Dr. - Sharlands
- 3 - S. Virginia - Sierra Center Pkwy
- 4 - W. 7<sup>th</sup> - N. McCarran
- 5 - Keystone - W. 4<sup>th</sup>
- 6 - 8<sup>th</sup> - N. Virginia
- 7 - Mayberry - S. McCarran
- 8 - Silverada - Oddie
- 9- S. Virginia - Kietzke
- 10- Plumb - Kietzke

High visibility enforcement was initiated at listed intersections with a focus on enforcement and education. The impact of traffic and crash reduction team officers

enforcement and education efforts, resulted in elimination of all crashes at six of the ten intersections and drastically reduced the crashes at the remaining four intersections.

Not only is the TCAR approach effective in reducing injury crashes, it also places a focus on traffic law enforcement as a problem solving tool in reducing crime in general. Deploying resources from the Traffic Division to the right places at the right time enhances police presence in the troubled area and is an effective counter

measure to deter and erode crime. The recent application of high visibility traffic enforcement netted immediate results last week when two motor officers, working a residential burglaries hot spot in the Central District arrested an individual responsible for numerous daytime residential burglaries.

Starting June of this year, the Traffic Division will release its monthly traffic report to the media. The report will highlight top ten crash locations in Reno and inform the public of the top contributing factors which caused the crashes. The citizens should expect highly visible traffic police presence in those areas for increased enforcement.

The Reno Police Department Traffic Division is committed to improving traffic safety and service through education, integrity, leadership and pride.
