## Guest Speaker May 2010 – Judy Henderson, NNADV

May's guest speaker was Judy Henderson the Education & Outreach Manager at the Nevada Network Against Domestic Violence (NNADV)

Judy spoke to members and guests about Domestic Violence and its impact on the work place. Although most people think of domestic violence as a problem in someone's home,

Judy pointed out that it effects the whole person and they cannot simply "leave their problems at home".

Domestic violence can happen to anyone of any age, race, gender,

religion, culture, or economic status. Although 85% of victims are female, men can be victims as well. The abuse can include physical, emotional, financial, sexual, and stalking or some combination of several types. Although it is often blamed on genetics, stress, illness, substance abuse, or problems with the relationship, these are rarely causes; but merely excuses. Abuse is often a learned behavior through experience, reinforcement, culture,

family or community. The behavior can be changed if the abuser desires to do so and is held accountable for their actions.

Domestic violence incidents are seldom isolated and the abuser often com-

mits several other crimes in the course of the abuse to intimidate and threaten the victim. Other crimes can include prop-

erty damage, theft, false imprisonment, rape, stalking, kidnapping, arson, homicide and others. These crimes are conducted against the victim, their friends, family, coworker, and even pets. The crimes are intended to elicit a response from the victim and maintain control or perceived control of the victim.

The crimes can have greater impact when the victim is elderly, lives in an area with limited resources, is isolated by the abuser, has disabilities, or is dependant on the abuser to care for them.

Victims often feel trapped in an abusive relationship, not realizing there are resources available to assist them in assisting behavioral changes in the abuser or to help



The abuser may take clothing, vehicles, money, or restrict food to the victim making it very hard or impossible for the employee to consistently get to work on time or increase absenteeism.

Physical abuse can cause the employee to stay home to recover from injuries cause them to have increased hospital visits and increased health costs to the employer.

Additionally there is a liability for employers to protect their employees. NNADV shows liability nationwide averaged \$1.2 million

with settlements averaging \$600,000.

Judy reported that NNADV found 74% of victims were harassed at work including the harassment of other employees to assist in monitoring the victim's activities.

When employers reprimand the employee for their behavior, they may escalate the problem if they are not cognizant of the possible cause. While it is not the employers obligation to maintain an employee who is not performing for personal reasons, the employer may find greater benefit from offering assistance and keeping good employee rather than just

letting them go. The assistance can come from internal programs, but there are a wide range of programs, options and advice offered by NNDVA that can be accessed by the victim. ### Texas gun owners get to cut the security line—from Security Director News May

The Texas State Capitol officially increased its security measures on May 21, installing metal detectors and screening people entering the building, but in Texas, all screening measures are not created equal, according to the Associated Press: Officials are creating one line for the masses, one line for lawmakers and their staffs and then a separate procedure for concealed handgun license holders. The general public has to get scanned at the entrances. State officials and gun toting citizenry do not.

I know Texans love their guns, but come on, that's not really fair. The policy is based on the fact that those holding conceal-carry permits have already undergone background checks and training and, according to the state, do not pose a threat. But some out there are a little skeptical about this logic. "If you're planning on perpetrating something in the state capitol, you should simply get a concealed handgun license and show your gun on the way in," said Peter Hamm, spokesman for the

Washington-based Brady Campaign to Prevent Gun Violence. "It's just ludicrous."

While licensed gun owners do undergo an electronic scan of their permit to make sure it's up-to-date, some regulars in the building don't think it's fair that gun owners get to bypass security:

For frequent visitors of the capitol, including lobbyists, journalists and political activists, getting the permit just to get in faster is becoming an alternative to waiting behind tourists.

"I'm thinking about it," said lobbyist Bill Miller, who spends most of his life walking in, out and around the capitol when the Legislature is in session. "I mean, I don't want to wait in line. If that's the way you do the deal, I'll be happy to get the permit. I won't be carrying any weapons."

But then again, state budgets are tight. A little bump in revenue from conceal-carry permits certainly wouldn't hurt.
