Guest Speaker-September 2009, Christopher Wajda



Special Agent Chris Wajda is with the Criminal Investigation Division of the IRS. Chris emphasized that all income is taxable, even illegal income!

The IRS is a bureau of the Department of the Treasury. The IRS is organized to further the mandate of the secretary of the Treasury under section

7801 of the Internal Revenue Code. The secretary has full authority to administer and enforce the internal revenue laws and the power to create an agency to enforce them. The IRS was created because of this legislation. Section 7803 of the Internal Revenue Code provides for the appointment of a commissioner of Internal Revenue to administer and supervise the execution and application of the internal revenue laws.

The IRS's Mission is to foster confidence in the tax system, apply tax laws fairly, and help

taxpayers understand and meet tax obligations. In exchange, taxpayers are expected to understand their obligations and to comply with them.

In addition to helping compliant taxpayers, The IRS also extracts compliance from those unwilling to pay. In support of the overall IRS Mission, the IRS Criminal Investigation Division serves the public by investigating potential criminal violations of the Internal Revenue Code and related financial crimes in a manner that fosters confidence in the tax system and increases compliance with the law.

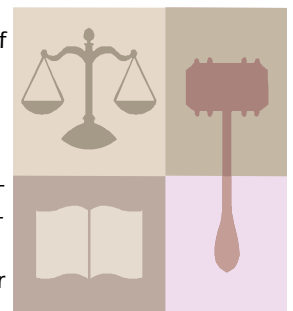

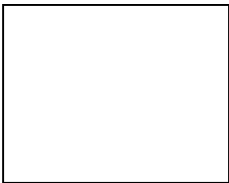
