Following are some comments from James Stewart, who was the recipient of the award for the CPP Review only. We also have the rare pleasure of sharing some of the personal photos taken by our RVP, Ron Sathre. I recently received the Jack Buckley Fund scholarship to attend the CPP review in Anaheim, CA. For anyone who is signed up to take the CPP test or who has taken the CPP test. you know that studying for it can be a daunting task. I looked at all of the material that the CPP test questions are taken from and a person can get discouraged. I was honored to receive the scholarship and had great expectations from attending the CPP review. I was not disappointed.

From the moment I arrived, I knew this was going to an excellent course. That was because they had a wonderful breakfast and coffee buffet set up (Just kidding). We received a binder with a course outline in it and got to work. The instructors were dynamic speakers and extremely knowledgeable. They stressed areas that were surely to be on the test and added "Good to know" information that will simply help security directors in the future. This kind of excellent instruction went on for two days.

I believe a good way to know whether or not a course was beneficial was to ask whether you left frustrated or with increased knowledge and understanding of the subject matter. For me it was defi-

Guest Speaker-October 2009, Chris Smith

Washoe County School District

Emergency Management Director Chris Smith was the October Guest Speaker. Smith is a former teacher and principal with the district and a reserve deputy with the Washoe County Sheriff's Office.

Smith presented an overview of the school district's planning and response strategies to a variety of potential threats: medical/health, fire, outside threats, natural disaster, and hazardous materials.

Smith reported that emergency response teams with pre-determined roles are activated to respond to a variety of emergency scenarios.

Smith emphasized the importance of advance planning so that every responder knows what to do and also knows what other responders are doing. Smith also emphasized the need for redundancy so that participants are reliably available at all response levels.

Finally, Smith reported that emergency response generally involve the need to either shelter or evacuate, depending on the nature of the emergency. In all, the emergency response tactics of the school district appeared to provide a good template for application in commercial environments.


