Chairman's Corner–Darrell Clifton, CPP

Well, it happened again. One of my own fellow managers referred to our security officers as "Guards". If you just heard nails on a chalkboard, then I know you agree with me. For those of you that have no idea what I am talking about, here goes: In my experience, security officers do not like being called "guards". I don't know about you, but I certainly did not like it. It brought all of my training and hard work down to one trivial noun. It was a term that we used in our circle when an officer made a mistake or acted like an idiot.

I asked some of my officers about this and even a couple of security professionals from my ASIS network. Most of them agreed the term was diminutive, if not derogatory. However, I noticed that many of our national contract security companies refer to their services as "guard" providers. At least one even has the word in its name. I have not spoken to any of those guys, but you would think that their employees probably feel more like numbers or pieces of meat rather than valuable talent being paid the highest dollar.

What image does the word "guard" conjure in your mind? For me, it is one of those German sentries at that lonely border crossing with a shack and a gate. "Who goes there?" I also think of those British fellows in front of Buckingham Palace. They seem to be more of a show-piece rather than even a "guard". I also think of a guard as that thing on my bicycle that keeps the chain from falling off. Yes or No. Entry or not. Now when I think of "Officer", I think of someone who is well-trained, professional in appearance, and is able to make rational and deductive decisions that affect others. We refer to our police as officers; we even call the guys who graduate military academy "officers".

All joking aside, can we all agree that a guard is someone who makes simple yes or no decisions, such as reading an ID at an access point to determine entry, or observing intruders and eavesdroppers and reporting same to someone with proper authority to take appropriate action. I suppose if that is the way you train your staff, then "guard" is an appropriate term. However, if you train your employees to arrest people, depriving them of their basic liberties, exposing your company to million-dollar lawsuits; or to watch over hundreds of thousands of dollars in cash or merchandise; or even protect the lives of your employees and customers from violent criminals; shouldn't you at least respect their efforts enough to call them officers? If you call them guards, that is what you're likely to get. If you call them officers - or better yet, ask them what they want to be called – you are likely to get that professional that you want.

CPP Exam Scheduling

CPP Candidates have a two-year period of eligibility from the date of application approval to prepare for and pass the CPP exam. Eligible candidates in the U.S. and Canada may schedule an exam date and location for the computer-based exam by contacting Prometric on the Web or by calling +1.800.699.4975.

Audited Certification Courses

Auditing a certification review program is an option available to individuals who have attended an ASIS certification review program or a complete online review in the past two years. Auditing is only applicable to the same program previously attended. Auditing is not applicable to people who have attended chapter reviews. Audits include speaker outlines but no study guides. Audit registration is not available online, by fax, or via mail. Be prepared to indicate the date and location of the review you attended. Please call+1.703.519.6200 to register to audit a review program. Pricing is subject to change. Please note that auditing is available ONLY for certification review programs. Fees are \$350 for members and \$450 for nonmembers to audit.
