- Nominees, or their respective organization leaders, must be a member of the Northern Nevada Chapter of ASIS International.

The **Security Officer of the Year** award is our opportunity to honor a colleague who has admirably served in a uniformed security role consistently and professionally through the period and has exceeded expectations.

The **Security Professional of the Year** award is our opportunity to honor a colleague who has admirably served in a leadership role and provided security professionalism in an exemplary manner. Individuals who consistently provide leadership and willing to help any other professional at any time should be considered.

The **Outstanding Security Achievement or Valor** award is our opportunity to recognize that remarkable or brave officer who may have saved the life of another or went above and beyond during an incident or emergency. This is the opportunity to recognize that outstanding achievement or that incident of valor.

When submitting your nomination, please be as detailed as possible regarding their achievements and performance that qualifies them for this honorable award. The nomination form is a critical factor in the selection process. Individuals may not self-nominate.

Please take a moment in your busy day and consider your colleagues and associates for any of these prestigious awards. Anonymous nominations will not be accepted.

**Deadline for submission is June 15, 2017.** All submissions will be reviewed by the Chapter Awards Committee, then forwarded to the ASIS Northern Nevada Executive Board for review and final voting. The finalists in each category will be invited to the May luncheon meeting where they will all be recognized and the winners announced.
